RESOLUTION ADOPTING THE ASSESSMENTS OF UNPAID CITY CHARGES


WHEREAS, the City Administrator-Clerk-Treasurer has compiled a list of unpaid charges for City services and has notified the persons responsible for such unpaid charges of the City's intent to assess the unpaid charges against property owned by said person; and


WHEREAS, pursuant to proper notice duly given as required by law, the Council has met and heard and passed upon all objections to the proposed assessment of unpaid City charges,

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF WAITE PARK, MINNESOTA:

1. Such proposed assessment of unpaid city charges for City services, is attached hereto and made a part thereof, and further hereby accepted and shall constitute the assessment against the property owned by said persons therein receiving the City service, and each tract of land therein included is hereby found to be benefited by the City service of the unpaid charges in the amount of the assessment levied against it.
2. The owner of any property so assessed may, at any time prior to certification or the assessment to the County Auditor, pay the whole of the assessment on such property, with interest accrued to the date of payment, to the City Administrator-Clerk-Treasurer, except that no interest shall be charged if the entire assessment is paid within 30 days from the adoption of the assessment. The owner may at any time thereafter, pay to the City Administrator-Clerk-Treasurer the entire amount of the assessment remaining unpaid, with interest accrued to December 31 of the year in which such payment is made. Such payment must be made before November 15 or interest will be charged through December 31 of the succeeding year.
3. The Administrator-Clerk-Treasurer shall forthwith transmit a certified duplicate of this assessment to the County Auditor to be extended on the property tax lists of the county. Such assessments shall be collected and paid over in the same manner as other municipal taxes.


